Conversation with the Senior Minister	Justin Schroeder	Justin reviewed some highlights of his written report in the Board Packet: The church has issued for the first time a summer "program guide"Justin participated in the dedication of a Habitat home recentlySeveral members have been meeting with Justin as an outgrowth of attendance at two recent presentations about diversity and inclusion. Justin explained the recent \$10,000 grant that we received from the UU Funding Panel (see Board Packet) to help fund the "Minnesota Marriage Equality Pastoral Care Outreach Project." The grant, along with contributions from other UU congregations, will be used to create a video studio and to produce educational messaging in opposition to the marriage amendment. Laura Smidzik, who will be our intern minister next year, will manage this project. Craig Bierbaum asked whether we can capitalize on the investment in video production capacity to enable greater outreach to new communities. Justin invited other questions about the written report. Lark asked about the plan to develop a new membership database that will allow us to capture and use information about the interests of members as well as administrative information for mailing and pledge tracking. Justin and Susan Claeys explained the functionality of this database and its benefits. Staff is currently evaluating software options. Craig Bierbaum asked whether this software can be used to expand our outreach through social media and outreach.		

Finance Committee report	Nancy Gaschott	Nancy reported that the recent finance monitoring committee meeting included an evaluation of this year's committee activity. There was discussion about the distribution of committee meeting minutes, which have been included in the Board Packets published on the website. It was concluded that these minutes should be circulated directly to the board and included as an addendum (Attachment A) to board meeting minutes. Nancy reported on the committee's request for monthly financial reports directly from the accounting system in addition to the annotated quarterly reports that are so valuable. Susan Claeys has agreed to provide this information going forward. Justin attended the recent committee meeting and announced that he intends to attend future finance monitoring committee meetings, and that Susan Claeys will attend board meetings in the future. The board will receive summarized quarterly reports; the committee will receive these reports in greater detail. Nancy pointed out that the board can request any reports that it wants at any time. The plan however is to depend on the finance monitoring committee to do the in-depth review with summary data going to the board. Craig Bierbaum asked whether these distribution standards should be captured in the Governing Policies Handbook. It was suggested that this matter be added to other changes to the GPH that are planned for this fall. David Bach suggested that we keep our language about such reporting requirements in the GPH as broad as possible.

Discussion of Unity Center		Justin introduced the context for this issue, which was raised at the May board meeting as a concern about the relationship between the Church and Unity Center for Youth Leadership and associated liabilities. Susan explained the research that staff has undertaken in the last month. Staff has concluded that Unity Center never fully launched as an independent enterprise. Because of this and because its mission is aligned with that of the Church, it is recommended that it again be considered a program of the Church. The potential dissolution of Unity Center as a separate Minnesota corporation will be considered by its board next week, and is expected to be approved by that board. An action plan is being developed to incorporate the program into the Church administration and budget. Kathy Coskran asked what would be different in the Unity Leadership (Center) program under this structure, especially in regard to funding and content. Justin and Susan reported that there are lots of points of alignment but details have not been resolved. The board's primary concern was liability and that has been clarified. Dan asked about the financial implications and employment terms for Deb Rogers. Craig Bierbaum asked about staff in addition to Deb. The Unity Leadership (Center) program will report to Jen Crow. Notes from First Universalist Church Finance Committee Meeting

#### 1. Justin on Unity Leadership and its relationship to the church:

The committee has been legitimately very concerned about the lack of clarity in the church's relationship to Unity leadership, and its consequential liabilities and responsibilities. Recent conversation and a great deal of research by Susan shows that it never successfully launched as its own non-profit organization. Now with the focus articulated in the strategic plan, and with the program's own evolution, it's appropriate to bring it back to the church as a program of the church. Executive Director Deb Rodgers is on board with this decision.

#### Some facts:

Total budget is approximately \$95,000. (For more details refer to the financial report and budget as distributed at the Annual Meeting.) It has \$16,000 in a cash reserve. It's received funds from individuals, from LISC, and from the UU Funding panel.

#### Next steps:

UL will need to be unincorporated by resolution of the Unity Leadership board, which will dissolve it. MAP for Nonprofits is helping.

The church board will then consider the proposal that Unity Leadership will become a program of the church. Its resolution, for clarity, should include language that UL's employees have always been employees of First Universalist Church.

The federal employer's ID number will need to be voided.

Individual donors will need to be engaged. The task force that's described in the strategic plan will need to be convened to oversee the program's full integration into the life of the church.

#### 2. Evaluation of Committee's Work

#### A. The Timing of the Committee Minutes

At times conversations occur at committee meetings that should not immediately be shared with the congregation, as they are once they're published in the board packet.

Solution: the minutes can be shared as confidential documents via e-mail with the board, and can then be published in the following month as an attachment to the minutes of the board meeting.

#### B. Monthly Financial Reports

Justin and Susan recommend that the committee can and should expect detailed quarterly reports, including projections for the year end.

Nancy suggests that, in addition, on a monthly basis Susan should provide a print-out of a set of financial statements. Susan explains that the current church system isn't user friendly enough to do this in an automated format that would produce timely or easily understood reports.

Question: When will the QuickBooks conversion happen?

Answer: As early as possible in FY12-13. Resources required to complete this project along with other priorities are being evaluated.

We agree on this for the quarterly reports, thus amending the monitoring schedule slightly.

September: Year End Close
November: 1st quarter report
February: 2nd Quarter report
May: 3rd Quarter report

The committee requests that, with the conversion to QuickBooks, simple monthly financial statements should be produced for the committee.

Susan wants to be on record saying that she questions the value of monthly statements that are not interpreted and offers the opinion that quarterly reports with year-end projections are more meaningful. She further suggests as an alternative to monthly uninterpreted financials a monthly report of key financial indicators (e.g. pledges, fundraising).

(In subsequent conversations between board members and staff, all agreed that church staff will provide monthly financial statements directly from the accounting system to the committee, in addition to the detailed quarterly reports.)

#### C. Board Designated Funds

The board designated funds should be reconsidered by the Finance Committee, and policies written to define their size, purpose, and manner of investment.

Perhaps they could be invested, not in the same way that the Legacy Funds are, but in a more liquid way, and a way in which any interest they earned could be recognized as income.

Presentation of Strategic Plan	David Bach, Trustee	David reported that the full version of the five year Strategic Plan is available for viewing on the church <a href="website">website</a> ; however, a summary is printed in the <a href="Annual Report">Annual Report</a> . He thanked those in the congregation who had contributed to the planning effort, either online, by attendance at one of many "working group" sessions designed to gather input, or by direct contact with members of the team. David provided background on the history of strategic planning for the church and the process that guided this effort. The essential questions guiding this work have been: Who are we called to be? What are we called to do? How do we become the church we long to be? David added that this is not a plan that will sit on the shelf. The trustees are firmly committed to seeing it into reality. He invited all members and friends to join in this commitment.	
Treasurer's Report	Nancy Gaschott, Treasurer	Treasurer Nancy Gaschott, who completes her third and final year as treasurer, provided an overview of the three years—which were marked by our effort and commitment to understand what "policy governance" means for the finances of the church and for the role of the board of trustees. Under this governance structure, the committee and trustees need to focus more exclusively on policy and less on the day to day finances of the church. Three years ago the focus of the committee was on the church balance sheet, ensuring that it accurately reflects the restrictions and donor intentions related to the assets of the church. The second year was focused on bringing financial practices of the church into compliance with Generally Accepted Accounting Principles (GAAP). Finally, the third year focus has been on revising policies to ensure effective monitoring of the church's financial condition, and alignment of our investment policies with the needs of the church. Nancy acknowledged that member Ross Levin continues to be a generous and valued volunteer for the church, managing our investments on a <i>pro bono</i> basis. Nancy highlighted two areas of concern that were raised this year, both of which have been addressed by staff in a satisfactory manner: These issues were related to deficit budgeting, and the need for clarity about the church's relationship with Unity Leadership and any liabilities that might accompany that relationship. Nancy referred to a supplemental handout, the Unity Center for Youth Leadership Annual Report 2011-2012.	

Rev. Justin Susan Claevs, Dir. of Finance and Admin.

Justin began a review of the proposed 2012-13 budget, which is Schroeder & presented in greater detail in the Annual Report. He summarized the many programmatic developments that will make the coming vear an exciting one for all: Continuing dynamic worship and music ministry; the arrival of Rev. Jen Crow as Minister of Program Life; ambitious plans for faith in action, membership and adult ministries. including the launch of "Wellspring" which is a signature program established by Rev. Crow. Our new ministerial intern, Laura Smidzik will focus her efforts on teaching and learning. Justin completed his remarks with a high level review of financial and membership trends at the church.

> Susan Claeys began a PowerPoint presentation of the budget for 2012-13, along with actuals for 2010-11, and the budget and yearend projection for 2011-12. Discussion focused on the budget for coming year. The more detailed budget is in the Annual Report (see p.22-27 of Annual Report). The budget is balanced, but staff acknowledges that there are revenue challenges in these figures. Susan indicated that progress will be monitored closely by staff and that the Financial Monitoring Committee will have quarterly status reports and projections. Our bylaws call for approval by the members of a capital budget as well as the operating budget, so Susan presented the 2012-13 capital budget (see p.28 of Annual Report). She thanked the team of volunteers and staff that has prepared a detailed five year analysis of capital needs, from which this current budget is drawn. A supplemental handout provided details of the Church Reserve Accounts (see Attachment B).

#### Motion to approve Budget. Moved and seconded

Approximately fifteen minutes was devoted to questions from the Members. These included concerns about (1) the environmental impact of a capital budget item to resurface the parking lot; (2) the revenue projections in the operating budget; (3) reduced commitment to our annual dues owed to the Unitarian Universalist Association and the Prairie Star District of the UUA; (4) policy of charging fees for religious education classes; (5) need to make further capital investments to improve energy efficiency of the building; and (6) contingency plans if revenue projections fall short of budget. To this last matter, staff responded that revenue would be tracked closely and that they are prepared to make expense cuts to maintain a balanced year end result. There was also a question about whether the formula for fair share dues for the UUA is being reevaluated. Justin indicated that this was his understanding.

The question was called.



Sr. Minister Report prepared for the Board of Trustees, August 2012

**Mission Statement:** In the Universal Spirit of love and hope, we give, receive, and grow. First Universalist Church.

#### **Visionary Goals:**

The people of First Universalist Church grow in their UU faith: we are equipped to live out our values and experience worship, spiritual practices, and rituals that challenge, comfort, celebrate, and heal.

This summer, the "Standing on the Side of Love" sermon series has challenged, comforted, celebrated and healed. Ruth MacKenzie, our Summer Minister, along with other guest preachers, have dug deeply into this topic, and the worship services have educated, inspired, and touched our hearts. We have been called to work for immigrant justice, and to really live our faith as we have conversations about why love, commitment, and marriage matter, as we seek to defeat the marriage prohibition amendment in November. These summer sermons have dug into the nuances, nooks, and crannies of these issues, and have explored both the complexities and joys of what it means to "Stand on the Side of Love."

Ruth MacKenzie has continued to lead the *lectio divina* spiritual practice sessions through the summer and those have been well received.

We also offered 7 small groups during the summer, for new members, young adults and others. For the first time, staff members participated in their own small group this summer. The staff met a total of 6 times, and it was a transformative experience. There were two clear wins: 1) we are more connected to and bonded with one another as staff, and 2) staff now has a greater understanding about the importance and power of small groups in our faith community.

First Universalist Church is a home for ageless wisdom. People of all ages find opportunities to engage in an intellectual and spiritual search for deeper meaning and understanding in the UU tradition, both as individuals and in community. We know our roots, find our wings, and apply our knowledge and wisdom to all our endeavors.

The Rev. Jen Crow is on board and we're building a fabulous working relationship. Together, we are stretching, collaborating, and planning. Jen Crow is getting to know the Program Team (Debra Rodgers, Lauren Wyeth, and Heidi Mastrud) and they are hard at work creating a program guide for the fall. The program guide, like the summer program guide, will contain opportunities for people to "know our roots, and find their wings," as they give, receive, and grow.

This summer, we've held two all church book studies; in addition, on August 19th, Michael Dowd (author of "Thank God for Evolution") and his wife will speak here, offering several

classes, and learning opportunities, in addition to the Sunday morning sermon. (You can learn more about Michael here: <a href="http://michaeldowd.org/">http://michaeldowd.org/</a>).

This summer, for the first time, we offered program for middle school aged children, lead by Katie Heaton. We also offered a fun and compelling summer program for children, our "Seven Principles Summer Passports." Our children have journeyed with same age friends (4 years through kindergarten, 1st-3rd grade and 4th-5th grade) as they collect stamps in their Seven Principles Summer Passports. Our "travelers" will choose activities that reflect their interests as they learn about our faith, and are invited to follow up with fun activities at home. Feedback from parents has been positive.

We're also planning a teaching training and orientation for the fall. This will include the nuts and bolts of teaching, but also include the theological underpinnings of our faith, and invite RE teachers to reflect on their teaching ministry.

First Universalist Church is an intergenerational community of mutual caring and support. We build this community by actively welcoming all and encouraging each other to discover, develop and share their gifts.

Lauren Wyeth and the Family Ministry Team held an intergenerational potluck/pie eating get-together at the end of July. Over 50 people attended. By all accounts, it was a wonderful event, and helped people connect with one another. Fun, care, and support were evident.

A great number of people shared their "gifts" as we rebuild the choir loft in the sanctuary. A special thanks goes out to Dan Bishop, Weld Ransom, Chuck Coskran, Dennis Sherwood, and countless others. The newly designed choir loft is beautiful. There are still a few final pieces that we need to take care, so that we're up to code; our facility staff, in partnership with congregants, is working on these final details.

The people of First Universalist Church work to build a just, loving and sustainable world. We are a visible, influential voice, and we act to shape the larger community into a more just and equitable society.

On August 10, Jen and I, and other members of First Universalist attended the MN Sikh Temple to sit in prayer with them, to pray for the lives lost in the Oak Creek, WI, shooting, and to condemn violence in any house of worship. In an email, we invited the congregation to join us:

As most of you have likely heard, this past week a man walked into the temple of the Sikh Society in Oak Creek, WI and shot and killed six people. Earlier this week, our Senior Minister, Rev. Justin Schroeder, reached out to the Sikh Society of Minnesota to offer our condolences and to share our support. As the Sikh community mourns, they have asked us to do three things:

- to join them in prayer for those who have died
- to learn more about Sikhism
- to denounce any violence against anyone, in any house of worship.

This Friday, we have the opportunity to stand with the Sikh community in the spirit of love. Please consider joining Rev. Justin Schroeder and Rev. Jen Crow at a prayer vigil at The Sikh Society of Minnesota at 7:30pm to honor those who lost there lives this past weekend. May the spirit of love enfold us as we learn and pray and mourn together.

We were also visible in the community when our children set up a "Lemonade Stand-ing On the Side of Love" to raise money in support of MN United for All Families. A special thanks to Lauren Wyeth, the Family Ministry Team, and the many adults and children who helped make this happen. We "came out" for Marriage Equality at our Lake Harriet Service: we were an ocean of yellow shirted "Standing on the Side of Love" people!

On Sept 30, at 6pm, we are holding a metro-wide UU service at First Universalist to inspire and charge people to continue to work to defeat the marriage prohibition amendment. We are still working out details, but we know that Unity's choir will be joining First Universalist's choir, their may be a children's choir, and that a variety of Twin City UU ministers will participate in this service.

Finally, the MN Standing on the Side of Love Video Project is off to a great start. Laura Smidzik, our 2012-2013 intern, in spearheading this project, and will be working on it as part of her internship.

#### **Updates:**

#### **Budget:**

The congregation based a 2011-2012 budget that had a \$106,000 deficit. Preliminary results are that we're ending the year with a \$22,000 deficit.

#### **Capital Improvements:**

We've started on improvements that were part of the 2012-2013 capital budget. The North sidewalk was poured last week. We're ordered new railings for the front steps. We've ordered two bike rikes. We're getting bids on railing for the balcony. The fire escape has been repaired. We're working with the fire marshall to make sure we understand room capacity and fire safety for our building and classrooms.

#### **Database Update:**

We have a project plan for database implementation. We've selected the software.

#### **Shared Ministry Teams:**

Susan and Trish have created a "rentals team." Susan is in the process of creating an auction team.

#### Staffing:

Minister of Program Life: It has been a delight getting to know and work with Jen Crow. Her large church experience is evident, her love of people and Unitarian Universalism is contagious, and we are having a blast together! She is spending a great deal of time getting to know the program team, and building relationships with them. There is an energy and synergy in our work together, and we are bringing out the best in each other.

Interim Communications Coordinator: Our Interim Communications Coordinator is Craig Lindahl-Urben. We have posted the Communications Coordinator position, and will be interviewing for it later this month.

**Front Desk Reception:** We've re-imagined this position; instead of a front desk receptionist, we're looking to hire a Assistant Office Administrator, who will support the office staff, and oversee and coordinate the front desk volunteers (we'll created a training program for the front desk volunteers and a formal job description, so everyone is clear about what's needed and expected.) We believe this has the potential to be a strong "win," as the Administrative Staff will get the support they need, and church members will be able to share their time and hospitality in a meaningful way at the front desk (and feel connected to the life of the church.)

#### Staff Leadership:

**Leadership Retreat:** On August 14 and 15, the Ministers, Program Directors, and Intern held a leadership retreat offsite. We spent time team build, learning, playing, and creating goals for the year, based on Strategic Plan.

All Staff Retreat: On August 22, we'll be holding an all staff retreat, as we dig into the Strategic Plan, and the goals for the year.

### THE TUNNEL OF CHAOS

One of the greatest contributions author and psychiatrist M. Scott Peck made to this world was to shine a spotlight on the differences between participating in genuine community and experiencing what he coined "pseudo community."

If community involves things such as knowing and being known, serving and being served, loving and being loved, and celebrating and being celebrated, then most relationships, Peck asserted, are constantly devolving into pseudo community. It's the great temptation for small groups of people to slide into a state where they're not *quite* telling each other the truth and they're not *quite* celebrating each other. Instead, they tolerate each other,

they accommodate each other, and they settle for sitting on the unspoken matters that separate them

Years ago, what captured my imagination about Peck's concept was the aha that in order to move from pseudo community to genuine community, you have to endure a little chaos. To break free from falsehood, someone has to upset the applecart and say out loud, "As far as I can tell, we're not experiencing real community here. We're not where I want for us to be,

anyway. Frankly, I'm holding back. I'm not giving you the final 2 percent of what I'm thinking. And I'm not really hearing what you have to say, either."

When I taught on this idea at Willow, I drew two circles on a flip chart and labeled the one on the left "Pseudo Community," the one on the right "True Community."

"We all want to get to true community," I said, "but we find ourselves in pseudo community. So how do you move from one place to the other?"

I added another element to the drawing, a tunnel that connected the two circles. "You have to be willing to go down into a tunnel," I explained, "a tunnel called chaos."

As I continued, I asked the congregation to think of the three most important relationships in their lives, such as those with their spouses, family members, close friends, or business partners. "How many of you know that you're settling for pseudo community with at least one of those three people?"

More than half the crowd raised their hands—quite interesting, given the fact that nobody in his or her right mind actually wants to live in lessthan-true community.

We settle for pseudo instead of demanding the real deal for one simple reason: fear. "What if airing the issue actually make things worse?" we think. "What if probing the situation only serves to ruin the relationship?"

To these fears and more, there's only one response: the tunnel. Frightening as it is to enter that tunnel, those who do are the ones most likely to pop up one day into the fresh, life-giving daylight of true community.

I've been in hundreds of pseudo-community situations in which the only option was for me to invite the other person down into the tunnel. We'd be sitting across from each other in a restaurant, our food would have been served, and there would come that awful and awkward point when there was nothing else to say except the one thing that had to be said: "This is quite likely going to be a difficult conversation," I'd start, "but I'm committed to working this through no matter what it takes."

And then the back-and-forth would begin as we both recounted the steps that had led to our relational demise: "I meant this," and "You said that," and "Here's where I think we lost our way."

Chaos would actually be a tame way to describe some of the exchanges I've experienced in this regard. Sometimes it all feels downright scary. It's messy. It's ambiguous. It can be ugly. But it is almost always worth it.

Recently one of my ministry cohorts came unglued during a creative session. We were trying to finalize some video footage, and right after I gave a few minutes of candid input on her work thus far, she burst into tears. The response was atypical, so immediately I knew something else was fueling such a dramatic display of emotion. There was an awkward silence for a few minutes as I sat there wondering what to say or do.

I prayed a quick prayer for wisdom from God and then asked the only question I could think to ask: "What's it like to be sitting in your chair right now?"

She explained the frustrations she was feeling and the stress she had been under, and suddenly I realized she had been in a jam for quite some time. "How terrible it would be to feel that alone and that overwhelmed," I replied.

We went on to talk about where the train had left the tracks and what we could do to get it headed in the right direction once more. In half an hour's time, all was well again. But had we not been willing to dig down into that tunnel of chaos where tough questions demand candid answers, there might well still be tension between us today.

Ministry is a series of battles, and a lot can get said on the front lines that may not be exactly edifying. Every leader must constantly ask direct reports, chief lieutenants, key donors, and the best volunteers, "Are we okay? How can we clean up the messes we've made along the way?"

Stay prayed up, rested up, and committed to entering the tunnel of chaos whenever the Spirit prompts. It's one of the truest tests of character and love.8
