#### III. Informational Items

**a.** Dick reported that the Connected Volunteers project will be kicked off from the pulpit on Nov. 5. He shared a memo containing the roll out plan for the project.

#### IV. Financial Report

**a.** Rev. Crow had circulated a memo from Kurt Hochfeld, our financial consultant, containing his recommendations on a variety of issues. He urged transparency about the annual pledge results (lower than last year) as well as any cuts that need to be made to the 2017-18 budget as a result of the pledge shortfall. He also commented on the contingency fund and repayment requirements, capital allocations and fiscal agency issues.

Regarding the revised budget requested by the Board at its September meeting due to the pledge shortfall, Rev. Jen made the following recommendations to reduce the budget by \$75,000: \$25,000 in additional income (10% of a recent bequest and \$15,000 from old check write offs), legitimately allocating \$25,000 of staff time that will be spent on capital campaign issues, such as moving, to the capital budget, and \$29,235 of expense cuts provided by the program directors. Rev. Jen noted that, per Kurt, a staff overhead allocation could also be moved to the capital budget, something she has not yet done.

The \$75,000 reduction was predicated on receiving an additional \$45,000 of pledge income from prior pledgers, only \$11,000 of that has been pledged to date. The revised budget is based on pledge income of 1.1M; we are currently at 1.075M. Although we may get more income from prior and new pledgers, Rev. Jen perceives that even with this \$75,000 reduction, there is still a gap that will need to be bridged.

The Board is comfortable with the proposed program cuts but requested that Rev. Jen specifically apply the racial justice lens choice points to the cuts before they are finalized.

# IV. Proposed Building Collaboration with Shir Tikvah

a. Eric asked Jen and Dick, who participated in the recent meetings with Shir Tikvah, if they any amendments or changes to the summary memorandum that he circulated to the

Board. Rev. Jen felt that Shir Tikvah is more open to option 2 (a lease arrangement) than the memo indicated, although probably as an interim solution to see how "living together" works out.

The Board assessed a potential building collaboration with Shir Tikvah against the congregation's visionary goals. The consensus was that the collaboration would primarily enhance our visionary goals, with some negatives.

The Board then moved to applying the racial justice choice points, or racial justice lens, to the potential building collaboration. After extensive discussion the Board agreed to continue the building collaboration discussions with Shir Tikvah with two caveats: first, that it is clearly stated to Shir Tikvah that our congregation's commitment to racial justice is a bedrock commitment that will guide our continuing conversations; and second, that if a decision is made to move forward with a building collaboration, financial gain resulting from that decision will be committed to the congregation's racial justice work.

#### Sr. Minister and Executive Minister Report to the Board of Trustees, Nov 16, 2017

**Opening Reading and Reflection**: Blessing for the Broken Hearted by Jan Richardson

There is no remedy for love but to love more.

Henry David Thoreau

Let us agree for now that we will not say the breaking makes us stronger or that it is better to have this pain than to have done without this love.

Let us promise we will not tell ourselves time will heal the wound, when every day our waking opens it anew.

Perhaps for now it can be enough to simply marvel at the mystery of how a heart so broken can go on beating, as if it were made for precisely this as if it knows the only cure for love is more of it, as if it sees the heart's sole remedy for breaking is to love still, as if it trusts

that its own persistent pulse is the rhythm of a blessing we cannot begin to fathom but will save us nonetheless.

**Reflection Questions:** What is breaking your heart right now? What is saving you right now? As always, is this poem stirs something else in you that these questions don't point to, please speak to that.

**Sabbatical Update:** During my sabbatical time, I studied and read about what it means to racialized as a "white" person, including how being racialized as a "white" person impacts my body, my emotional capacity/bandwidth, and the ways I move through the world. I read several books related to this topic, including "Learning to White," by Thandeka, "White Rage," by Carol Anderson, and started "My Grandmother's Hands: Racialized Trauma and the Pathway to Mending," by Resmaa Menakem. Mostly significantly, during my sabbatical, I met weekly with Susan Raffo, a founding member of the "People's Movement Center," at 41<sup>st</sup> and Chicago. (You can learn more here: http://www.peoplesmovementcenter.com/.)The work with Susan was particularly focused on the ways that whiteness and white supremacy conditioning and patterning live in my body, and show up in my ministry, my parenting, and my life. I found this time to be incredibly helpful, as I able to feel and sense in my body the ways that white supremacy was impacting my capacity to be fully human.

#### **Monitoring Items:**

Staff and Volunteer Grievances: No formal grievances have been filed or reported.

Transitions in Staff and Volunteer Positions: Jerrod Wendland, our pianist, is leaving at the end of November. Franco Holder, someone highly recommended by Jerrod, and who has played at First Universalist before, will begin as our new pianist in December.

Financial documents for this month, including a report on Capital Campaign income and expenses, our first quarter review, as well as income and expense and balance sheets for September will be provided to the Board at or right before our meeting on Thursday.

# 2017-18 First Quarter Financial Summary Prepared by Rev. Jen Crow November 15, 2017

#### **Summary**

At the end of the first quarter, expenses exceed income by roughly \$30,000. As you can see below in the detailed information about our income, roughly \$14,000 of this deficit will be resolved before the end of the year. The remaining \$16,000 of that gap can be attributed to the typical front-loading of start-up expenses in the church year, as well as the decreased pledge base.

#### Income

We have currently received income in the amount of \$454,203, which is approximately \$45,000 below what we would have expected compared to our approved budget. This difference comes from three main sources, one is that our pledge base is significantly lower than budgeted, the second is that rent payment from our major tenant was delayed, and the third is that income from our music fund is not shown here.

Given that our pledge base is currently \$1,080,000, not the \$1,115,775 listed (which includes a 5% uncollectable rate on the approved pledge base of \$1,174,500), we are actually ahead in the collection of pledges. One quarter of \$1,080,000 is \$270,000, and we have currently collected \$327,000 in pledges for the year.

The delayed rent payment accounts for \$8,667 of that difference in expected income for the first quarter. Southside was late paying rent in both September and October. All payments are currently up to date, but because September's payment was paid in October, it is not included in the first quarter's income.

Also income from the music fund is not shown (\$5900), but was included in the approved budget. Because this income comes from a temporarily restricted fund, it could not be included in this report due to restrictions in our accounting software. Please note that this amount is consistent with the deficit amount listed for our annual budget in this report.

#### **Expenses**

Expenses are tracking significantly under budget. Staff have made many adjustments to reduce spending in order to offset the anticipated reduction in income for this year's budget. It is also true that many expenses are front-loaded in the year: classroom supplies, dues & memberships, and any other costs associated with the ramp up in church events in the fall. Staff compensation related to our building project has been tracked and reallocated to our capital building project budget as approved by the Board. I anticipate seeing our expenses coming in even more under budget, and in line with our income, in the second quarter.

#### **Additional Information**

Originally, staff had expected to present a draft budget for our Capital Campaign expenses at the November Board Meeting. Plans have been delayed, however, as the architects do some additional research and focus in on a preferred direction for our project. Also, a draft copy of the end of year assessment conducted by our financial consultant, Kurt Hochfeld, has been provided to the Board President and Treasurer. A few minor details are still being wrapped up, and a final copy will be provided to the Board for its December meeting.
