Spiritual Grounding

Change comes from collective action. Yes, individual effort and will matter, and when our individual will and effort are gathered in accountable community in service to a vision - we are transformed individually and collectively. Or, as we say here at church,

Individual and collective transformation arise out of regular spiritual practice + accountable community + vision.

In the spirit of digging deeper into the sources that can support us in our individual and collective transformation, I offer us Five Questions from Charlene Caruthers, presented in her book, *Unapologetic: A Black, Queer, and Feminist Mandate for Radical Movements*.

The Five Questions:

- Who am I?
 - What is at stake for you in this church? With your faith?
- Who are my people?
 - "Who are your people?" is a question meant to agitate. It is meant to help us become clear about who we identify with and push us to make connections where they aren't obvious or comfortable."

- What do we want?
 - "Working together for transformative change means shared vision, and it means
 that there will be moments of discomfort. As an organizer I need to be clear about
 what I know well but also about what I do not know. I must recognize when I am
 out of my depth on issues, ideas, and strategies."

- What are we building?
 - "Each generation of struggle lays the groundwork for the next."
 Carruthers, Charlene A. . Unapologetic (p. 104). Beacon Press. Kindle Edition.

"Whether we are building institutions or running experiments, we have to decide what exactly we're doing. If you enter the room expecting to work on a thirty-year strategy while I am expecting to craft short-term experiments, how do we work together? I'm not asking that we find a middle ground—both approaches are necessary—but how do we connect those strategies for a larger purpose? Our movement must be flexible enough to deploy multiple tactics and disciplined enough to carry out strategies that move us toward collective liberation." Carruthers, Charlene A. . - Are we ready to win?
 - "Gopal Dayaneni of Movement Generation says that "if we are not ready to govern, then we are not ready to win." He goes further to say that if we aren't ready to govern, then we don't even deserve to win. Governing is not

synonymous with becoming part of the governments we live under—or duplicating them.... Governing is the process of making decisions that impact groups of people. How are we governing in our organizations and communities? Decision-making in these sites of public government impacts the private decision-making in our families and relationships. Governing impacts every domain of our lives. Our movements must and can work toward a decision-making culture that produces different terrains in which we live our lives. The time is now to experiment and implement practices that match the type of world we want to create."

Where You Go I Will Go - Summary

Following a meeting open to the congregation on Sunday, April 21 at 1pm, and an invitation for feedback and thoughts over email, Dr. Glen Thomas Rideout, Director of Worship Arts Ministries, offers this summary.

Dear Ones,

After thoughtful reflection and listening to your voices, I have decided to gradually phase out 'Where You Go I Will Go' from our worship services, with plans to introduce a new

traditional song by January 2025. This decision was reached through deep engagement with your insights and our shared values, not in isolation.

For those interested, I've compiled my reflections and the ethical and spiritual questions raised by this issue into a detailed document. I engaged this deliberate process to honor and hear what we've shared, and meet it with my best attention. To honor the openness of the process we have created together, I am making it available to you.

While a decision is made, the conversation about our shared traditions remains open. If you would like to continue in dialogue, please reach out; I would be happy to share time and thoughts together.

As we move forward, I warmly invite each of you to help shape the new musical expressions that will resonate with our community's spirit. Thank you for your trust, your understanding, and your deep engagement as we navigate this change together.

Ministerial Internship(s) 2024-25

We interviewed two candidates for ministerial internships, and selected one candidate, Elliott Nassif, to complete a part-time, 2-year internship with us beginning in August. This internship will be fully funded by the Cummins Ministerial Internship Fund.

2024-25 Budget Assumptions

Our operating budget is a tangible expression of our values, our vision, and our mission. How we spend our money is one of the most important tools we have as we strive to align our institutional practices, our resources, and our outcomes with our visionary goals. Responsible financial stewardship, caring for our congregation and our community, and progress toward our newly adopted visionary goals guide our planning. We also continue to analyze and review of our current ministry and program offerings and what is needed for the present and the future of our church and Unitarian Universalism.

Mission:

In the Universalist spirit of love and hope, we give, receive, and grow.

Visionary Goals:

The people of First Universalist practice Beloved Community among and beyond us. To do this we...

- Honor the richness of our Unitarian Universalist faith and embody its love within the walls of our church and beyond.
- Foster our connection with, care for, and action on behalf of Earth's environment and all of life.
- Pursue our individual and collective work for justice, in relationship with those most affected by systems of oppression.
- Widen the opportunities for leadership participation and engagement in the many facets of how our church functions and thrives.
- Provide meaningful presence to one another in times of joy, grief, and change.

As we prepare our annual budget for 2024-25:

- We will present a balanced budget, with a realistic income # based on past performance and planned fundraising efforts
- Meet annual health insurance cost increases and other necessary expense increases impacted by inflation
- Bring staff salaries which are below UUA salary recommendations up to minimum recommendations within 2 years
- Include a 3% cost of living increase for all staff
- Plan for the costs of sabbatical coverage
- Increase giving to the UUA annual fund as possible

Rev. Jen consulted with the Finance Committee to create 3 possible 2024-25 budget scenarios for review.

Worst Case Scenario

- Realistic, planned for projections in fundraising and income (\$1,282,000 in annual giving)
- Partial restoration of facilities hours (35 hrs/wk, and 30 hrs/wk) both benefits eligible
- Some salaries adjusted to meet UUA minimum guidelines
- No increase to UUA Annual Fund giving
- \$5000 for sabbatical coverage

Worship/Music staffing at 1.25 FTE

Expected Case Scenario


- Realistic, planned for projections in fundraising and income (\$1,314,000 in annual giving)
- Partial restoration of facilities hours (38 hrs/wk and at 30 hrs/wk) both benefits eligible
- All positions at UUA minimum salary guidelines
- 3% cost of living increase for some staff
- 3% increase to UUA Annual Fund giving
- \$5000 for sabbatical coverage
- Worship/Music staffing at 1.25 FTE


Best Case Scenario

- Realistic, planned for projections in fundraising and income (\$1,330,000 in annual giving)
- Full restoration of facilities staffing and hours
- Salaries for all positions meet minimum UUA guidelines
- 3% cost of living increase for most staff
- 5 hrs/wk of administrative support
- 5% increase to UUA Annual Fund giving
- \$5,000 for sabbatical coverage
- Worship/Music staffing at 1.25 FTE
