Senior Minister Board Report Prepared by Rev. Jen Crow November 18, 2024

Spiritual Grounding

In this time of fractured aspirations for our country, I am turning to many different wisdom sources for direction and accompaniment in discerning what is needed in this moment.

The poet, Andrea Gibson, shared this in a "Post-Election Letter to a Friend" recently.

"Last April, after two years of chemotherapy, when my oncologist told me the cancer was now considered incurable, I felt the expected fear and grief. But something I didn't tell you was this—I also felt relief. Why relief? Because when I heard the system say, "We can't save you," it was the first time since my diagnosis that I felt as if my life was in my hands. Watching the election, I felt something similar: grief, fear. Then this thought—*Our lives are in* our *hands*. They always were, but it's clearer than ever now.

I keep asking myself, "What is my job in this moment? What do I specifically have to offer?" It's empowering to ask those questions because no one's job will be the same. There were many years of my life that I did not feel I was actively participating in change unless I was in the streets protesting. As my health worsened, I knew that wasn't where I would be of most service. Creatively explore where you might be most useful. Throw a *What's My Job* party and explore the question with your community. Friends may reflect a specific talent or gift they see in you that you haven't yet recognized."

There is clarity in this moment - we are in each other's hands. And each of us, and this faith community, will have a job to do in the days ahead. As leaders of this congregation, the discernment of what our particular work in this particular moment will be is ours to share. Grounded in our particular heritage of Universalism that proclaims a love so powerful that no one is outside the circle and all must be treated as the whole and holy and worthy beings that they inherently are, what is ours to do?

I'm grateful to have our visionary goals to guide us, and a clear purpose already articulated. And, as the social and political landscape that we live within changes in the months and years ahead, we will continue to be called into discernment about this particular congregation's role in offering spiritual nourishment, community care, and faithful action that empowers, protects, and stands in solidarity with the most vulnerable people in our community and our planet.

Now is the time to take stock, literally and figuratively, of our resources and our liabilities. What do we need to learn, and learn quickly? What do we already know about ourselves and each other? What spiritual practices, what practices of building Beloved Community, can we lean into? What resources do we have among us, and what do we need to cultivate and seek out? What habits and patterns do we fall into that do not serve us and our role in the world?

On November 6th, the author, Rebecca Solnit, shared this on Lion's Roar: Buddhist Wisdom for our Time.

"You are not giving up, and neither am I. The fact that we cannot save everything does not mean we cannot save anything and everything we can save is worth saving. You may need to grieve or scream or take time off, but you have a role no matter what, and right now good friends and good principles are worth gathering in. Remember what you love. Remember what loves you. Remember in this tide of hate what love is. The pain you feel is because of what you love.

You can be heartbroken or furious or both at once; you can scream in your car or on a cliff; you can also get up tomorrow and water the flowerpots and call someone who's upset and check your equipment for going onward. A lot of us are going to come under direct attack, and a lot of us are going to resist by building solidarity and sanctuary. Gather up your resources, the metaphysical ones that are heart and soul and care, as well as the practical ones.

There is no alternative to persevering, and that does not require you to feel good. You can keep walking whether it's sunny or raining. Take care of yourself and remember that taking care of something else is an important part of taking care of yourself, because you are interwoven with the ten trillion things in this single garment of destiny that has been stained and torn, but is still being woven and mended and washed."

Let's take care of ourselves and each other, and let's find our role individually and collectively.

First Universalist Church of Minneapolis Finance Committee Meeting Minutes 20 November 2024 6:00-7:30 pm

Members present: Dan Berg, Marc Gorelick, Julie Most, Cameron Smither Staff present: Brad Schmidt, Jen Crow Stewardship liaison present: Will Hegeman

Meeting convened at 6:04 pm

- 1. Chalice Lighting
- 2. Minutes from the prior meeting (10/16/24) were approved
- 3. YTD financial results were reviewed.
 - a. Through Q1 (Jul-Sep 2024), revenue continued to be well ahead of budget (\$245,000), believed to be mostly due to timing. Expenses running a bit over budget but with a few concerning trends (see below). Current surplus is \$189,000, compared with YTD budget of a \$38,000 deficit.
 - b. Year-end projection based on Q1 results shows projected deficit of \$30,000 (on a breakeven budget). Notable variances include:
 - i. Total revenue projected slightly (\$~8000) ahead of budget
 - ii. Buildings and grounds expense projected \$13,500 over budget due to need for security services
 - iii. Program expense projected \$11,000 over budget due to increased Minneapolis minimum wage for childcare
 - iv. Personnel expense projected \$14,000 over budget due to unexpected workers com charge (\$5000) and increased uptake of health insurance by family members
 - v. Jen and staff to develop ideas for expense reductions to offset these variances. It was also noted that the need for facility security in the current political climate could also be an opportunity for fundraising to meet that need.
- 4. Stewardship update.
 - a. Give to The Max has already exceeded the original \$10,000 goal, with actual GTM Day not until tomorrow! This represents more than 1/3 of the original fundraising goal, with 2 additional main events planned: youth fundraising event, and a spring event (likely a concert).
 - b. Stewardship team continues to work on promoting messaging around generosity tied to our values.
 - c. Thank you notes to donors almost caught up. Going forward, members will receive quarterly reports of their giving through Breeze (first report due to go out in October).
- 5. Long-term Debt.
 - a. At the interim finance update to the congregation, Marc presented information on our construction loan. We currently pay approx. \$132,000 annually, which is largely the interest on the loan at 3.75%, with a balloon payment of \$1.5M due in fall of 2031.

Interest rate is due for revision in October 2026 based on the 5-year treasury rate plus 0.8%.

- b. We are currently considering options for addressing this:
 - i. Capital campaign to raise the money to pay off on schedule in 2031.
 - ii. Raise money to pay off the loan early.
 - iii. Refinance in 2031 (e.g., mortgage, bonds, etc.)
- c. Marc and Brad will work to draft a document to outline the current status and options, with scenario plans for various potential interest scenarios and timelines, with a goal of developing a plan to decide on the definitive approach by the end of the current fiscal year.
