## Senior Minister Board Report Prepared by Rev. Jen Crow December 16, 2024

#### Spiritual Grounding

As we move into these winter months I find myself entering into a time of reflection. Below I'll share with you the collage of readings we shared in worship on December 8th for our service on Healing from Trauma in December series of worship services centered on the visionary goal of providing meaningful presence to one another in times of joy, grief, and change.

As you sit with these quotes -I wonder which ones speak to you in your own personal life, which ones might speak to you as you reflect on our congregational life, and which ones speak to you as you reflect on our national life. As we build and practice Beloved Community within and beyond the walls of our church, connecting quickly and easily with the "why" of our efforts is essential. Do any of these quotes speak to a "why" for you?

So much of the prophetic wisdom of faith traditions around the world and throughout history comes from those whose lives sit at the margins and whose hearts have chosen to speak boldly that view. Let us hear these voices -mostly black and brown, some queer and non-binary, all embodied prophecy -calling us into a posture of listening and transformation of ourselves and the systems of harm that made their work necessary.

## First Universalist Church of Minneapolis Finance Committee Meeting Minutes 6:00-7:30 pm

Members present: Dan Berg, Marc Gorelick, Julie Most, Dick Niemiec, Cameron Smither Staff present: Jen Crow Stewardship liaison present: Will Hegeman Guest present: Jeff Snyder

Meeting convened at 6:00 pm

- 1. Chalice Lighting
- 2. Minutes from the prior meeting were approved
- 3. YTD financial results were reviewed.
  - a. Through October overall surplus of \$122k (vs. budgeted YTD deficit of \$50,000)
  - b. Revenue \$200k ahead of budget driven by pledge income
  - c. Expenses \$33k over budget, driven by similar variances as Q1
  - d. New projected variance of \$11,500 in personnel due to need for additional ministerial support during Rev. Arif's LOA
  - e. YE projection of \$40,000 deficit remains
  - f. Rev. Jen beginning to work with staff to identify expense reductions to return to balanced budget. Few opportunities that would not impact programming.
  - g. Caution regarding trying to rely on increased revenue to offset the budget gap since fundraising already a stretch goal, and 2025-26 pledging needs to compensate for large one-time pledges in the current year.
- 4. Stewardship update.
  - a. An additional fundraising opportunity has been identified (January Peter Mayer concert in conjunction with other area churches). Financial pro forma is being developed, but encouraging opportunity to meet fundraising goal.
  - b. Stewardship team is working with Rev. Jen and staff to launch 2025-26 pledge drive early (late December) so that staff and congregation can focus on the work of the church.
- 5. Investment performance. Deferred to January.

Meeting adjourned at 6:45 pm

#### New development and its impact on the budget.

- Contracted Minister, \$11,500 negative impact to budget

#### Year to Date/Year-End Update

- Overall, not a significant a deviation from the Q1 year-end budget forecast both positively and negatively.
- Contracted minister will have a significant impact to projected year-end deficit. Additional \$11,500.

#### Investment Update

- Investments were consolidated to one account and invested in socially responsible holdings.
- As far as what has happened and what's to come, I provided Ross Levin's quarterly report who knows more about than I do.
- Our investments did take a hit in October but Ross predicted volatile markets.
- Net return of 12.49% this calendar year.
